Bishop's Council has continued to approve in 2024 the historical recognition of the PCC element of fees in relation to crematorium or cemetery funerals or premises belonging to funeral director.

Accordingly, the DBF will donate from its fee for each funeral in a crematorium or cemetery or premises belonging to funeral director (£228 in 2024 onwards (£217 in 2023)) the value of the equivalent proportion originally granted in the 2019 PCC fee. All those with Permission to Officiate who are retired will be eligible to receive 80% of the balance of the DBF fee, after deduction of the donation to the PCC element (£35). In 2024, this will amount to 80% of £228 minus £35, i.e. £193.00. Payment will be handled by the relevant PCC and the settlement to the DBF through the reporting and payment system.

Please note that DBF fees can only be waived following permission from the relevant Archdeacon.
