^{*}Bishop's Council has continued to approve in 2025 the historical recognition of the PCC element of fees in relation to funerals in premises belonging to funeral directors.

Accordingly, the DBF will donate from its fee for each funeral in a premises belonging to funeral director (£234 in 2025) the value of the equivalent proportion originally granted in the 2019 PCC fee. All those with Permission to Officiate who are retired will be eligible to receive 80% of the balance of the DBF fee, after deduction of the donation to the PCC element (£35.00). In 2025, this will amount to 80% of £234.00 minus £35.00, i.e. £19.00. Payment will be handled by the relevant PCC and the settlement to the DBF through the reporting and payment system.
